Damage Reporting

Don't forget you now are now required to report damages to the commission within 45 calendar days. If you have not already registered with the commission's VirtualDIRT, [click here](#). **If you have registered, it is important that you "share" your DIRT data.** If you do not share your data, the commission will not receive your reports and they will not be included in Washington's damage statistics. To share your data, company administrators need to select the "Grant Data" option on the main menu. For more detailed instructions, [click here](#). Safety Committee Update

Question of the Month

With the new law now in effect, we thought it would be helpful to publish a question we have received pertaining to the new dig law in each update. Remember, the commission is here to help with any questions or issues you might have.

Q: If an email address is not available when providing information regarding unlocatable facilities, can certified mail be used if it is sent within the two business day requirement?

A: Unless there is a mutual agreement between the parties, the utility operator would have to guarantee that the available information has been delivered to the excavator within two business days in order to comply with requirements of 19.122.030(4)(a).
