PASSENGER RULES

ADULT FARES: Published fares are adult fares and apply to passengers who have reached or passed their twelfth birthday. (Seniors will receive a two dollar discount for one way tickets.)

ANIMALS: Animals, birds or other pets will be transported if they are caged and present no harm to other passengers. Service animals will be allowed in the passenger area of the vehicle but must lie on the floor near the owner and not on the seats. No service animal will be allowed next to the driver but must be to the rear of the driver.

Animals will be transported without the owner at the adult rate. A ten dollar charge will apply if the owner accompanies the animal.

CHILDREN FARES: Children under six years of age will ride free. The child must be in a secure child seat not on the lap of the parent. Children under twelve and up to six years old will ride for half fare.

OBJECTIONABLE PASSENGERS: This company will not transport persons under the influence of drugs or alcohol, persons who are incapable of caring for themselves, or whose conduct is objectionable to other passengers or present a risk to the safe operation of the vehicle and security of the driver and passengers.

ROUND TRIP FARES: An eight dollar discount will be subtracted from the total price of a round trip. Seniors will receive an additional five dollar discount.

SCHEDULE MAINTENANCE: The company will not be liable for delays caused by accidents, breakdowns, bad conditions of the roadway, snow storms and other conditions beyond the control of the company and does not guarantee arrival at or departure from any point at any specific time.

STOP OVERS: Stop overs will not be allowed.
