10	<p>Unless otherwise provided, the rates herein cover transportation of biohazardous, infectious, contaminated and other related infectious medical wastes, in specialized container, for the permanent disposition of such products as specified on the title pages herein. All rates shall be in addition to:</p> <ol style="list-style-type: none"> 1. Actual service fees charged for professional evaluation of medical waste streams and packaging requirements as necessary to comply with all applicable regulations. 2. Special clean up (decontamination) time and expense charges which may result from improper packaging or emergency requirements of generators. 3. Box system - A receptacle made of cardboard that is double lined with red plastic bags for protection. At time of collection, boxes are sealed airtight and shipped to the disposal site for incineration of all contents including the box. 4. Tub system - A receptacle made of rigid plastic with a tight fitting lid and is leakproof and puncture resistant. The tub is lined with red plastic bags for protection. At the time of collection, tub is sealed with lid and shipped to disposal site. At the disposal site contents are removed and incinerated. Tub is then cleaned and sanitized and is available for reuse by another customer. <p>The customer will have the option of using either a box system or a tub system.</p>

20	<ol style="list-style-type: none"> 1. The waste material to be properly managed by Twin City Sanitary Service is biohazardous/infectious waste produced by the generator. Title to all waste shall remain with the generator. The generator represents and warrants that the waste is as described by Twin City Sanitary Service in writing, all of the hazards and risks incident to the handling, storage, and disposal of the waste. Generator agrees to defend, indemnify and hold harmless Twin City Sanitary Service from and against any and all damages, penalties, fines and liabilities resulting from or arising out of any non-disclosure or misrepresentation as to the quality, hazards, risks and dangerous propensities of the waste material. 2. Transporter reserves the right to modify standard box sizes in the future provided cost per gallon equivalent remains the same unless and until conversion cost changes are approved the Washington Utilities and Transportation Commission.

The generator acknowledges that it has care, custody and management of containers owned by Twin City Sanitary Service and accepts responsibility for the containers and contents except when they are being physically handled by employees of Twin City Sanitary Service. Therefore, the generator expressly agrees to defend, indemnify and hold harmless from and against any and all claims for loss or damage to property, injury to, or death of any person or persons resulting from or arising in any manner of the use, operation or possession of the containers furnished by Twin City Sanitary Service.

4. Only properly filled containers will be picked up by Twin City Sanitary Service. No leaking, damaged or over-filled containers will be picked up by Twin City Sanitary Service. All containers must have sealed bag liners before they will be accepted for pick up by Twin City Sanitary Service.

5. The generator grants to Twin City Sanitary Service the right of access into its premises in order to carry out the services. The generator warrants that any right of way provided by the generator from the containers or storage lockers(s) location(s) to the most convenient public way is sufficient to bear the weight of all Twin City Sanitary Service storage locker(s) and vehicles required to perform the service.

6. The generator acknowledge that Twin City Sanitary Service shall not be liable for any damages to pavement or driving surfaces resulting from its trucks servicing an agreed upon area and generator shall defend, indemnify and hold Twin City Sanitary Service harmless from and against any and all claims for loss or damage to property, or injury to, or death of any person or persons resulting from the driving of said trucks in that area.

Residential Sharps Program

This is a service to provide residential customers safe disposal of sharps container. The charge for this service is \$19.85 per pickup. The collector will provide and deliver an empty sharps container to a location designated by the customer. There is a fee of \$3.25 for the start up and initial delivery of the empty sharps container. This is an on-call, non-routed, appointment only service. Accounts requiring return trips due to the unavailability of material to be collected for reasons within the control of the customer, will be assessed a charge of \$10.00 in addition to the regular charge. The sharps container will be a one gallon plastic container with locking lid, to be furnished by the collector. The collector will remove the full sharps container. The full container will be bagged and will include a written pickup receipt, signed by the collector, designating the pickup of a full sharps container. The collector shall be paid the fee for service at the time of providing the service.
