### **HHG Rule Updates**

The commission has adopted new household goods industry rules to provide clarification without changing intent, add requirements



for hiring new employees, and adopt changes streamlining the insurance process. The rules became effective Dec. 16, 2013. For more information, click here.

### **State Takes Action Against Illegal Mover**

The commission ordered Chana Green d/b/a Great American Moving & Storage to cease and desist operating as a household goods carrier and imposed a fine of \$5,000. The commission suspended \$3,500 of the penalty on the conditions that Ms. Green refrain from operating a household goods carrier without a permit and pay the remaining \$1,500 penalty within ten days of the final order issued Jan. 14. Ms. Greene subsequently failed to comply with the conditions for suspension. The full \$5,000 penalty was imposed on Feb. 25.

### **Frequently Asked Questions**

Forty-five movers attended the March 12 industry training in Olympia. Commission staff appreciated how the entire group interacted in a supportive and respectful manner to improve their knowledge of HHG rules. Below are answers to some questions asked in the last training.

### Q. Who must be enrolled in the drug and alcohol testing program?

**A.** Drivers must be enrolled in a drug and alcohol testing program if the driver is required to have a commercial driver's license (CDL). All drivers, including CDL drivers, are required to have in their possession a medical certificate if driving a commercial motor vehicle.

### Q. What are the background check requirements?

A. Each company shall provide the commission with evidence that the company has completed a criminal background check on each person it employs or intends to employ

# Q. When applying for a household goods permit, what criminal offenses will result in rejection of the application?

**A.** The commission will not grant permanent authority if any employee has, within the past five years, been convicted of any crime involving theft, burglary, assault, sexual misconduct, identify theft, fraud, false statements or the manufacture, sale, or distribution of a controlled substance. The commission may also deny an application if an applicant committed any of those crimes more than five years prior to the date of the application and the commission determines that the nature or extent of the crime(s) will likely interfere with the proper operation of a household goods moving company.
