LIMITATIONS OF SERVICE:

THE COMPANY SHALL PROVIDE NOTICE OF THIS REFUSAL TO THE COMMISSION AND TAKE ALL REASONABLE STEPS TO NOTIFY THE AFFECTED CUSTOMER(S) OF THE ACTION. FINALLY, THE COMPANY SHALL RETURN TO NORMAL OPERATIONS AS SOON AS IS PRACTICABLE GIVEN THE NATURE OF THE EMERGENCY UNDER WHICH THE ACTION IS TAKEN.
