TERMS AND RULES:

1. The ferry is operated on first come, first served basis.
2. All tickets must be used within one year of purchase.
3. **Infants:** There will be no charge for infants under 2 years who do not occupy a seat.
4. **Youth and Children:** All minors must be accompanied by an adult. Ages 2 through 5 are considered Children with a one-way fare of \$2.00, roundtrip fare of \$3.00, and hop-on, hop-off fare of \$6.00. Ages 6 through 18 are considered Youth with a one-way fare of \$3.00, roundtrip fare of \$5.00, and hop-on, hop-off fare of \$9.00.
5. **Adults and Seniors:** Ages 18 through 65 are considered Adults with a one-way fare of \$4.00, roundtrip fare of \$7.00, and hop-on, hop-off fare of \$12.00. Ages 65 and above are considered Seniors with a one-way fare of \$3.00, roundtrip fare of \$5.00, and hop-on, hop-off fare of \$9.00.
6. **One Way Pass:** When the service operates in a triangle or loop route the one-way pass shall at most include only a transit back to the original departure location.
7. **Hop-on, Hop-off Day Pass:** The hop-on, hop-off day pass is valid for unlimited rides on one calendar day. The pass is assigned to only one person and cannot be transferred or used by others.
8. **Ticket Limitation:** One-way tickets are good for one month from the date of sale. Roundtrip tickets are good for one month from the date of sale, but both trips must be used on the sale calendar day. Hop-on, hop-off day passes are good for one month from the date of sale, but all trips must be used on the same calendar day.
9. **Commuter Pass:** The commuter pass is valid for two rides per day for a 30 day period starting from the time of the first trip. The pass is good for six months from the date of sale. The pass is assigned to only one person and cannot be transferred or used by others. The pass is \$130.00 for a 30 day period for all ages.
10. **No Smoking:** Smoking of all substances is prohibited on all vessels. This includes all tobacco products, E-cigarettes and medical or recreational marijuana.

TERMS AND RULES (cont'd):

11. **Schedule Maintenance:** The company will not be liable for delays caused by accidents, breakdowns, weather or other conditions beyond its control. Though every effort will be made to meet the published time schedule, the carrier makes no guarantee to arrive or depart from any point at any time.
12. **Objectionable Passengers:** The company reserves the right to refuse to transport persons under the influence of drugs and alcohol, or who are incapable of taking care of themselves, or whose condition, conduct or behavior may be objectionable to other passengers. The company reserves the right to refuse carriage of any materials considered unsafe or not in the best interest of the passengers.
13. **Bicycles:** Bicycles are allowed in designated areas. Limited space available.
14. **Motorized Vehicles:** Motorized vehicles such as scooters or mopeds are not allowed onboard.
15. **Wheelchairs:** Wheelchairs are allowed onboard. Each vessel can accommodate only two wheelchairs.
16. **Animals:** Service animals, as defined by the Americans with Disabilities Act, will be carried free of charge. Service animals may not occupy passenger seats unless it is necessary to assist an individual with a disability. Pets that are leashed and well behaved are allowed on board at the discretion of the operator free of charge. Pet owners will be responsible for any extra cleaning/sanitizing of the vessel that may be necessary because of their pet.
17. **Lost and Found:** The company is not responsible for personal articles lost or left on vessels.
18. **Carry-on Items:** Carry-on items must be stored on your lap or at your feet. Baggage items must be stored in designated locations. Baggage charge is \$2.00 for every item over the first two baggage items per adult fare or one item per youth/child fare. Limited space for baggage items is available. The company will not be liable for loss or damage to baggage items carried on board the vessel.

21. **Refunds:** No refunds will be given for lost tickets. Subject to WAC 480-149-060(1)(a). Unused tickets will be redeemed at the purchase price if presented within one month of date of sale. Unused portions of round trip tickets will be redeemed by charging the regular fare of fares for the portion or portions used and refunding the balance of the purchase price. Roundtrip tickets must be presented for redemption within one month of date of sale. No refunds will be given for commuter passes. Passes must be presented within one month of date of sale.
