Definition of Terms and Description of Service

- (a) For services provided to customers under this tariff, the customers shall pay Murrey's Disposal Co., Inc. the rates as set forth in this tariff.
- (b) Company Warrents:
  - (1) It understands that currently known hazards which are presented to persons, property and the environment in the transportation, storage and disposal of the Bio-medical waste mateial.
  - (2) It will transport, store and dispose of the Bio-medical Waste material in full compliance with all Federal EPA and Washington State laws and regulations.
  - (3) The waste management facilities utilized are licensed and permitted to store and dispose of waste materials within the description of the Bio-medical Waste material profile.
  - (4) In the event such waste management facilities lose permitted status, customers will be promptly notified of such loss.
  - (5) Carrier will provide staff with initial and continuing training in handling, transporting and disposal of Bio-midical Wastes.
- (c) Customer Warrents:
  - (1) That the Bio-medical Waste material will be packaged in constainers meeting or exceeding health department minimum requirements and protected from damage until time of pick-up.
  - (2) It shall communicate, on an ongoing basis, the nature and content of the Bio-medical Waste material tendered for transportation and disposal, and will continue to communicate, those hazards and risks known to or learned by the customer to be incidental to the handling transportation, storage, treatment and disposal of the Bio-medical Waste material.
  - (3) If the Bio-medical Waste material is, or contains, hazardous substances as defined pursuant to Section 101 of the federal Comprehensive Environmental Response, Compensation and Liability Act of 1980, the customer will submit in writing, prior to tendering or delivering any bio-medical Waste material containing a reportable quantity of unapproved Bio-medical Waste substance or substance pursuant of Section 102 of said Act, specifying those hazardous substances present in a reportable quantity.

(4) If the Bio-medical Waste material is covered by requirements of any state laws or regulations relating to Bio-medical Waste or Bio-medical Materials, it will comply with all Applicable requirements of such laws or regulations.

(d) Service:

(1) Scheduled service shall be any service which is regularly scheduled as to specific date(s) or day(s) each month with consistent frequency.

~~(2) Minimum service shall be once per month. Minimum charge is \$20.85 per 5-gallon box and \$22.60 per 10-gallon box.~~

(2) On Call or Less-than-Monthly-Service is offered at \$15.00 a month. When on call service is requested, Murrey's Disposal will schedule a pickup within a reasonable time after request has been made. This minimum charge applies in any calendar month in which no pickup is scheduled. Regular charges on page 4 will apply when an on-call pickup is requested. (N)

(3) On call service is subject to a \$15.00 setup/delivery fee. (N)

(4) Container sizes offered are 5, 10, 20, and 35 gallons. Credit shall not be given for partially empty containers.

(5) Maximum weight allowance is as follows:

5-gallon container	15 pounds
10 gallon container	25 pounds
20 gallon container	35 pounds
35 gallon container	45 pounds

(6) Service area, Certificate No. G-9.

(e) Billing:

(1) Invoices will be calculated and mailed the last business day of the month. The total balance is due and must be received in our office no later than by close of business the last business day of the following month.

(f) Delinquent Accounts:

(1) Finance charges will be added to any account which remains unpaid thirty (30) days after the invoice date in the amount of 1 percent or \$1.00 whichever is greater, and every month thereafter until past due balance is paid in full.
