RE: 2013 Intrastate Propane/Air Peak Shaving System Standard Inspection – Puget Sound Energy - D.W. Swarr Propane-Air Plant

Staff from the Washington Utilities and Transportation Commission (staff) conducted a Standard Inspection from July 22-26 and July 29-31, 2013, of Puget Sound Energy (PSE), D.W. Swarr Propane-Air Plant. The inspection included a records review and inspection of the plant facilities.

No apparent violations were noted as a result of the inspection; however one area of concern was noted during the inspection which was corrected at the time of the inspection.

Section 2675.1200 of the PSE Operating Standards Manual (Effective on 03/01/13) — Propane Leakage Program Section 3.2, reads in part, "When conducting tests for leakage on buried propane gas systems, it is essential that samples be taken at or near the pipe, in the bottom of ditch lines, and at the low point of substructures."

Staff observed PSE leak survey contractor Survey & Analysis personnel performing a propane bar hole test only 12 inches below the ground surface. The propane pipeline is greater than 12 inches deep so the requirement for propane detection that "samples be taken at or near the pipe", was not met.

Propane leakage surveys were performed by excavating with a vacuum truck to just below and to the side of the buried pipeline. Permanent test wells have since been installed at these locations that will allow for proper leak sampling going forward.

Staff would like to thank PSE's professionalism, assistance, and cooperation during this inspection.
