**SECTION I
PASSENGER RULES**

There is no extra charge for baggage and no limit to the number of bags. Transportation of animals such as dogs traveling with sight or hearing impaired passengers, will be transported free of charge if they lie at the feet of their master and do not occupy passenger seats. Unused tickets will be redeemed at the purchase price and unused portions of round-trip or commutation tickets will be redeemed by charging the regular fare or fares for the portion or portions used, and refunding the balance of the purchase price.

SCHEDULE MAINTENANCE: Carrier will not be liable for delays caused by accidents, breakdowns, bad road conditions, snow storms, and other conditions beyond his or her control. Carrier does not guarantee to arrive at or depart from any point shown in its published time schedules. Schedules endeavor to maintain times indicated but, the same is not guaranteed. Any expenses incurred as a result of delayed departure or arrival time, including missed flights or travel connections, are the sole responsibility of the passenger.

RESERVATIONS: All pick-up times shown on time schedule for trips to Sea-Tac International Airport are by reservation only. Prepayment is required to guarantee a seat. This is to preclude overloading the bus or van. If the vehicle is in no danger of being overloaded, the passenger without a reservation will be carried to Sea-Tac and payment will be made by cash or charge card to the driver only at a service location where prepaid reservations are already held, or at a route service location beyond the vehicles current location. Drivers will depart service locations immediately after all reserved passengers are boarded.

REFUND POLICY: A customer who has made a reservation but fails to cancel, reschedule, or appear at the designated pick-up point by the scheduled departure time is not eligible for a refund unless the failure was caused by airline delay or cancellation.

LOST ITEMS: Notification of lost items or damage: Seattle Express must be notified of any loss or damage within 24 hours of transportation. We will make every effort to locate your item for you. Items left by Passengers that are recovered will be retained for 30 days and will be available for pickup on a will-call basis at our office (during regular business hours).
